6. ACCIDENTAL RELEASE MEASURES

6.1 Spills:

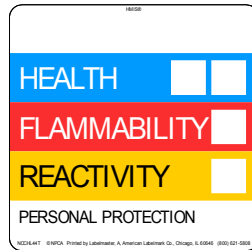

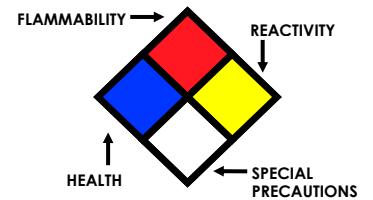
